Dear Parents / Guardians,

Welcome back to a new school term.. The following are some updates on our events and important notices:

Experiential Learning Week (07 to 10 Mar 2022) for Sec 2

1. I am delighted that we ended Term 1 with the Experiential Learning Week where students had the chance to spend time with their classmates and form teachers in various activities such as kayaking, rafting and kinball - a first time experience for most. The Gratitude Challenge also gave students a chance to reflect and express their appreciation for their peers. The programme ended with the Boomwhackers, a fun way for the students to perform as a class. It was definitely a memorable time spent together with their friends and teachers. In the coming days, we will continue to bring in activities for Bartleyans to have a meaningful and enjoyable school experience while adhering to Safe Management Measures, and help them to achieve their personal best.

Student Well-being and Developing Good Habits

2. We will continue to promote the well-being of our students through guiding them to build a sense of positivity and resilience. We also highlighted that the students should interact respectfully and graciously with one another as members of the Bartley family. We encourage parents to work with us, reiterating to our children the importance of healthy habits, respectful interactions and a growth mindset.
3. It is also important that our students practise responsible use of their mobile devices and Personal Learning Devices (PLDs). We would like to highlight that teachers expect mobile phones to be kept away during curriculum time and other school programmes, including CCA. Any use during these times must be with explicit permission from the teacher-in-charge. The PLDs are also to be used only for learning purposes. We emphasised to our students that mobile devices and PLDs should not be used for undesirable activities. We will continue to educate our students to be safe and responsible users of technology and would like to work closely with parents/guardians to manage device usage. Parents/Guardians could refer to pages 22 to 27 for our Acceptable Use Policy (AUP) Agreement in the Student Organiser distributed at the start of the school year.

Term 1 Progress Report

4. Students will receive their Term 1 Progress Report on 24 Mar 2022. Some of your child/ward's teachers may want to meet up with you to discuss your child/ward's progress. They will contact you to make the necessary arrangements.
5. When your child/ward gives you the Progress Report, we would deeply appreciate if you could use the opportunity to discuss his/her progress, and to plan how he/she could do better for the upcoming assessments together.

Attendance and Punctuality

6. For students to do well in school, it is important that they attend school regularly and punctually so that they do not miss out on the lessons and teachers' instructions. Students who are absent from school are to submit the relevant document(s) excusing their absence on the day they return to school. Students who fail to submit the document(s) supporting their absence within 5 working days of their return to school may face disciplinary action. **Per semester**, the school will accept up to a **maximum of 4 days of absence** covered by parents'/guardians' letter(s).
7. It is also important for students to participate actively in CCA so that they have a full learning experience. We seek continued support from parents to ensure that your child comes for school and CCA regularly and punctually.
8. Please note that your child/ward will be considered late for school should he/she arrive at the class after 7.30 am. An SMS will be sent to the registered official guardian by 9.30 am on days that your child/ward is absent from school.

Safe Management Measures (SMMs)

9. The school will continue with our daily visual screening. Students who are unwell or show symptoms of illness will be sent home to rest and parents/guardians will be informed. To continue to ensure the school remains a safe environment for all students, we seek the assistance and support of parents/guardians to guide our children to observe the following SMMs and exercise personal responsibility:
 - Students who are unwell with flu-like symptoms (e.g. fever, runny nose, cough) or have a positive COVID-19 Antigen test result are advised not to report to school.
 - Students are to wear high filtration masks except when performing strenuous exercise or eating/drinking. Students should refrain from talking when they are not wearing their face masks.
 - Students are to adhere to the updated MOH Health Protocol 1-2-3. If students receive MOH Health Risk Notice or have household members or close contacts who are tested positive, please inform their Form Teacher or the school.
 - Students are to bring their TT token or enable the TT mobile app to school.

Key Activities in Term 2

10. The key Sec 2 school activities scheduled for Term 2 can be found in **Annex A**. We seek your cooperation in ensuring your child/ward's participation in and/or preparation for the various activities the school has planned for them.
11. If your child/ward is scheduled to return for academic lessons and/or CCA training during the first week of June term break, a notification letter will be provided to you prior to the start of the activity.

Sec 2 Subject Options Briefing for Parents and Students

12. All Sec 2 students will participate in the Subject Options Exercise in Oct 2022 to select their Secondary 3 subject combinations after the release of the End-of-Year Examination results. There will be a briefing for all Sec 2 parents and students on Sat 23 Apr 2022, 9am to 11.30am. During the briefing, the available subject options and the various course requirements will be shared with parents and students. More details about the briefing will be provided through a separate notification letter and Parents Gateway.

Sec 2 Mid-Year Examinations

13. The Mid-Year Examination for Sec 2 students will take place between 10 and 18 May 2022. The examination timetable will be given to your child on 11 April and uploaded onto our school website. You will receive the timetable via Parents Gateway (PG) if you have subscribed to the PG mobile app. We will conduct a briefing on examination rules for your child/ward in school.
14. We would like to draw your attention to the following:
- Any student found cheating, or attempting to cheat, will be given a zero mark for the subject. All electronics, including smart watches etc. must be left in their bags and must be switched off at all times during assessments. Handphones should be locked up in their device lockers or kept in their bags.
 - Students should look neat and be dressed in their school attire to take the examinations. You may refer to pages 14 to 18 in the Student Organiser for the school rules on Attire, Grooming and School Uniform.
15. As part of our collaborative effort with you in developing and nurturing your child/ward, we would be grateful if you could supervise your child/ward in his/her revision to ensure that he/she sets aside time to prepare for the assessments, and also offer him/her your care and support.

BSS Community Day

16. The BSS Community Day would take place on Fri 27 May 2022. On that day, you will get the opportunity to meet up with your child/ward's teachers to find out more about your child/ward's progress via Zoom. We hope you can make yourselves available for the event. More details of the event will be given to you nearer to the date.
